### **ETHICS CORNER**

#### **FOOD FOR THOUGHT**

The relationship between a Professional Organizer and a client will occasionally evolve into friendship. The nature of our work, creating a safe and non-judgemental environment, the many hours required by certain contracts, and the mutual trust that develops between client and organizer all combine into a petri dish that transforms strangers into friends.

While this is mostly positive, these factors can also create circumstances that transport us into the grey area of ethics. Where and how do we draw the line between the professional and the friend? The overlap of friendship with clients can be confusing.

**Scenario:** After working with a client for many years on various projects, she reaches out to you to invite you over for coffee at her newly renovated house. She'd love to show you her new kitchen and catch up with you!

Your schedule allows for it, and you are quite looking forward to catching up, hearing how her business is evolving, what her kids are up to. As you plan your week and discuss it with your partner, you wonder to yourself "Can I say who I am meeting for coffee and where I will be or would that breach the POC Code of Ethics?".

Once you arrive at her house and settle in, you catch up on all the topics you've been looking forward to talking about. As you get up to put away your cup, your host remembers that she's been struggling with a few organizing systems in her new kitchen. She asks you what you would do with this situation and then catches herself,

apologizes because she doesn't want to seem like she invited you over just for free advice! You know her well and know she comes from a sincere place.

What are the 'right' decisions in this scenario?

- How do you simultaneously abide by the Code of Ethics and stay transparent with your partner when a client relationship evolves into a friendship?
- How could you address the situation with your client?
- Do you have a 'Friends and Family' rate, and if so, would this person qualify for it? Why or why not?
- How would you react in the situation where your client, now friend, asks for recommendations during your coffee date?
- In what ways could you prevent uncomfortable situations such as these?

#### **DID YOU KNOW?**

An exercise such as this, one that allows you to project yourself into a hypothetical scenario, enables you to determine what boundaries you wish to set ahead of time.

You might decide that you would rather never cross that line from client to friend. On the opposite end of the spectrum, you might notice that you attract clients to your practice that are types you enjoy spending time with and decide to allow some or many of them to step into friendship territory.

Some things to consider if you do open yourself to friendships with clients:

- What are the boundaries you abide by in your personal practice?
- Do these boundaries apply to all clients or are there exceptions?
- What are the exceptions?
- Might you or your client/new friend begin to feel differently about the exchange of money for professional organizing services?

As always, the best way to clarify any grey zones is through communication, and so we encourage you to discuss concerns early on with your client-friend.

'Clear is kind, unclear is unkind.' as Brené Brown says.

#### **New Condition for Silver Leaf Members**

Starting January 1st, 2022, any new member joining POC will now have to have obtained **35 service points** besides being a POC member in good standing, for a minimum of the previous two years, and having been a professional organizer for at least 5 years to become a Silver Leaf member.

All members who will have joined POC before January 1st, 2022, will not have to comply to this criterion (even though we suggest obtaining service points as well to prepare for your Gold Leaf status!). Points accumulated towards Silver Leaf can also be used towards attaining Gold Leaf.

There are nearly 15 different ways to earn service points. To know how many points are granted for each type of activity, have a look at the Gold Leaf Guidelines and Points Form on the Members only side of our website. (Soon to be added to the Silver Leaf Tab).

#### **Hoardig Clean-Out Study**

Fellow organizers, here is an opportunity to contribute to the profession.

Kate Kysow is a graduate student at the Centre for Collaborative Research on Hoarding. She is currently running a study on conducting hoarding clean-outs. She knows a subset of professional organizers do work with hoarding clients in terms of slower decluttering work, and that sometimes if there are external pressures, a professional organizer may do some very quick & intense work to help a client.

She has already had several professional organizers participate and their perspective was extremely valuable.

#### **Study Description:**

The Centre for Collaborative Research on Hoarding wants to know about your experience conducting a hoarding clean-out. We define "clean-out" as any rapid

intervention that greatly reduces the volume of clutter in a client's home. We know that clean-outs may be challenging for providers, but at times they are a necessary response to the health and safety hazards in hoarded homes.

Participation involves sharing your experience in a structured interview **via Zoom** that will take 45 minutes to complete. As part of the interview you will be asked about a specific hoarding clean-out you were involved in over the past 3 years. If you decide to participate, you will receive a \$25 honorarium. **Please contact Kate Kysow at 778-847-2059 if you are interested.**

#### **Twitter**


The Twitter audience saw the most growth this month with 10 new followers, likely thanks to the 2021 Summit. There were a total of 2,209 impressions.
