# **NATIONAL CONFERENCE COMMITTEE (NCC) News**

POC 2022 Virtual Summit – Call for Presentations

A "Behind the Scenes" Look at the Speaker & Presentation Selection Process

Each year POC issues a Call for Presentations where those interested in presenting at the national conference or summit (in person or virtual) completes a detailed online submission form for consideration by the National Conference Committee (NCC).

At the close of the submission deadline, the NCC Program Lead, Conference Lead and POC's Director of Education perform a robust review of all completed submissions to develop a short-list of qualifying submissions based on category, topic, diversity, and expertise/experience. This process results in a submission being accepted or declined. The conference program is then drafted with every effort made to offer a fresh, balanced, and educational event experience for participants within the session spots available in the schedule. The draft program is reviewed by the full NCC and POC board and then finalized.

The NCC encourages all POC members to make a submission to present at Summit through the Call for Presentations. It is only with your participation that we may continue to enhance the program topics and speaker diversity as the session selections are limited to the submissions received.

The POC 2022 Virtual Summit theme is "Passion • Purpose • Progress" and will take place Thursday, October 27, 2022 from 9:30 am – 5:00 pm Eastern time.

We are seeking new, interesting, and high-quality proposals from those interested in presenting via live stream for the Summit. This includes French language presentation submissions as the program may include a session in French.

Ethics is a system of moral principles which affect how people make decisions and lead their lives. A code of ethics is a code of moral standards of what is "good" and "right" as opposed to "bad" and "wrong". When joining POC, members are required to attend the *Ethical Standards for POC Members* course.

The main objective of the monthly Ethics Corner is to introduce a topic that will spark an interesting discussion at your next chapter meeting. # What Are Some of the Benefits of Volunteering at the National Level?

I couldn't believe how much I had in common with the local organizers I met with once per month. We can learn so much from each other's experiences and wisdom. When I applied for and received my Silver Leaf designation after 5 years as a member of POC in good standing, it meant so much to frame my certificate and hang it proudly on my office wall. I felt it was a remarkable achievement and added some credible experience and tenure to my business.

What can you gain by volunteering your time with POC?

1. You get to enjoy the camaraderie of our shared experience. Yes, we all have our niches and our specialities under the huge umbrella of organizing but for

- the most part, what we do is so similar. It's wonderful to network and share knowledge and resources to make our jobs and our client's lives better.
- 2. You might be aiming for a Silver Leaf or Gold Leaf designation yourself and need a few volunteer points to get to the threshold you're aiming for. Check out the website for more specific details on points accumulation and application requirements. Looking up from my desk at that framed certificate is both motivating and satisfying.
- 3. You might want to increase your marketable skillset or "street cred" by volunteering with a committee. It looks great on a resume or on your social media tag lines to mention that you are involved with a national organization representing professional organizers across the country. I always mention my volunteer involvement when I am meeting with potential clients for the first time.
- 4. You have mad skills and they should be shared! We come from a variety of backgrounds and we bring a wealth of experience to the table. Don't be shy to let your greatest assets shine by stepping forward to offer a hand to a committee looking for help. You might have translation abilities, media training, experience in event planning or even those amazing organizing skills of yours might be needed for a short-term volunteer commitment.

Please reach out to me if you want to discuss openings or volunteer positions that are available currently. I would love to talk to you about where your skills could be put to best use and the wonderful benefits of volunteering. Here's what we're looking for currently for short term volunteers...

- We are looking for someone to update the media training video.
- We need someone to do a very quick monthly translation from English to French (a few sentences).
- We would love for someone to come forward to create a national networking event outside of our conference. Imagine a national virtual drop-in event with interesting relevant guest speakers.

We are also looking for organizers just like you to fill positions on the following committees...

- The National Conference Committee (NCC) is seeking a Communications Lead and an Entertainment Lead. Wouldn't it be fun to have input on what happens at Conference?
- The Nominations Committee is looking for another member. You would be working with me to approve volunteer applications and come up with creative

ways to help organizers use their areas of expertise in volunteer positions as they arise.

 The Education Committee is looking for another person to help with education course revamping and roll out.

# Forming of the Diversity, Inclusion, Equity and Belonging Sub-Committee

Diversity, Inclusion, Equity and Belonging (DEIB) initiatives are a top priority for POC. We have heard our members' call for change and are forming a sub-committee. Our members know and represent our association best, so it is imperative to have your voices behind the scenes. In order to be effective, the DEIB sub-committee also requires the voices of under-represented groups in our industry - this applies to race, gender, language, religion, etc. from all across the country.

We need members who are passionate about the importance of diversity and inclusion and want to facilitate change.

The DEIB sub-committee will be lead by POC's Director-At-Large, <u>Crystal de Nobrega</u>.

The sub-committee will meet at least twice a month for 30 mins - 1 hr via Zoom from now until Mid-April. This is in preparation for April's Board meeting, where we aim to share our work with the Board, and where a policy about that topic will be written.

Ideally, once the framework for DEIB is in place, we will transition to meeting once or twice a month, depending on our objectives.

We acknowledge that this is a sensitive topic that is uncomfortable and challenging to discuss. We deeply appreciate the efforts already made by many of our members in this discussion.
