



## ETHICS CORNER / LE COIN ÉTHIQUE



### FOOD FOR THOUGHT

The Coronavirus pandemic has been circulating globally for more than two years and recent statistics report that close to 4 million Canadians have caught COVID-19 during this time. Increasingly, it is common place to know multiple people who have been infected and recovered. At the same time, federal and provincial health measures are ever-changing: Are you required to wear a mask? Are you required to be vaccinated to participate in public events? Are you required to quarantine at home if you test positive? Whether you agree with government regulations or not, it is helpful to have guidelines to navigate these uncharted waters.

Conversely, the government has not mandated if a person is required to verbally disclose their previous or current infection status to those around them. In Ontario, the government advises that a person infected with COVID-19 can go back to work 5 days after their symptoms first appear. In all likelihood, that person will continue to test positive on a rapid antigen test for days afterwards. How would you feel if you

were in the same space as a COVID-19 positive client for 6 hours and they didn't tell you? As a business owner, what are your duties in requesting this information? Furthermore, should clients, co-workers, and vendors who are recently recovering/currently infected with COVID-19 be obligated to disclose their status? There is still a stigma surrounding COVID-19 and not everyone is comfortable discussing their status. Perhaps you have already amended your standard contract to include your own vaccine status, your covid safety protocols, and what the expectation is if either you or your client gets sick. There are no easy answers, however, it is an issue that will be prevalent for the foreseeable future.

### **MATIÈRE À RÉFLEXION**

La pandémie de coronavirus circule dans le monde depuis plus de deux ans et des statistiques récentes rapportent que près de 4 millions de Canadiens ont attrapé le COVID-19 pendant cette période. Il est de plus en plus courant de connaître plusieurs personnes qui ont été infectées et guéries. En même temps, les mesures sanitaires fédérales et provinciales changent constamment : êtes-vous obligé de porter un masque ? Êtes-vous obligé d'être vacciné pour participer à des événements publics ? Êtes-vous obligé de vous mettre en quarantaine à la maison si votre test est positif ? Que vous soyez d'accord ou non avec les réglementations gouvernementales, il est utile d'avoir des directives pour naviguer dans ces eaux inexplorées.

À l'inverse, le gouvernement n'a pas rendu obligatoire la divulgation verbale de son statut d'infection antérieur ou actuel à son entourage. En Ontario, le gouvernement avise qu'une personne infectée par la COVID-19 peut retourner au travail 5 jours après l'apparition de ses premiers symptômes. Selon toute vraisemblance, cette

personne continuera à être testée positive sur un test antigénique rapide pendant des jours après. Comment vous sentiriez-vous si vous étiez dans le même espace qu'un client positif au COVID-19 pendant 6 heures et qu'il ne vous le disait pas ? En tant que propriétaire d'entreprise, quelles sont vos obligations lorsque vous demandez ces informations ? De plus, les clients, collègues et fournisseurs qui se rétablissent récemment/actuellement infectés par le COVID-19 devraient-ils être obligés de divulguer leur statut ? Il y a toujours une stigmatisation entourant le COVID-19 et tout le monde n'est pas à l'aise de discuter de son statut. Peut-être avez-vous déjà modifié votre contrat standard pour inclure votre propre statut vaccinal, vos protocoles de sécurité Covid et les attentes si vous ou votre client tombez malade. Il n'y a pas de réponses faciles, cependant, c'est un problème qui prévaudra dans un avenir prévisible.
